# ORDINANCE AMENDING THE ZONING ORDINANCE OF SOUTH HAVEN CHARTER TOWNSHIP TO REZONE M-43 PROPERTY

### **SOUTH HAVEN CHARTER TOWNSHIP ORDAINS:**

Section 1. Purpose.

The Township adopts the following amendments for the health, safety and welfare of Township residents.

## Section 2. Amending Zoning District Map.

The Township hereby amends the Zoning District Map ("Zoning Map") of the South Haven Township Zoning Ordinance to change the HC (Heavy Commercial) symbol and indication as shown on the Zoning Map for the following real property:

## Section 4. Repealer Clause.

Any ordinances or parts of ordinances in conflict herewith are hereby repealed only to the extent necessary to give this Ordinance full force and effect.

## Section 5. Effective Date.

This Ordinance shall take effect seven days after publication as provided by law.
