Rezoning Request Narrative

Parcel: 80-17-011-001-01

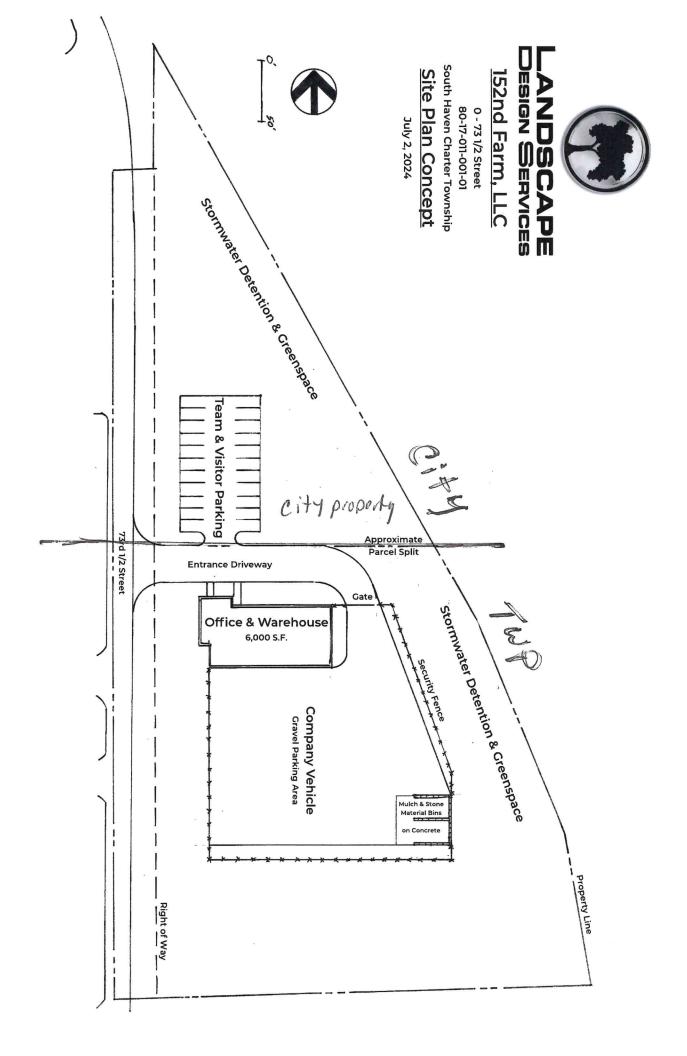
73 1/2 Street, South Haven Charter Township

The purpose of the request is to rezone the parcel from Highway Service Commercial to Community Service Commercial. Rezoning would match the Township parcels that are adjacent to the west and south of the parcel. 152nd Farm LLC has a purchase agreement on the parcel pending rezoning.

The entire larger property is unusual in that the north half was annexed by the City of South Haven splitting the property into two parcels. The concept for the site is to build a new warehouse and office on the south parcel inside the Township and utilize the north parcel inside the City for parking and stormwater detention.

152nd Farm LLC is a property holding company owned by both shareholders of Landscape Design Services, Inc. Landscape Design Services is a second-generation family business located between Holland and Grand Haven along U.S.-31. Founded in 1968 at the same location, the business has grown mostly organically to the north and south. The primary daily service area stretches from South Haven to North Muskegon. In the last two decades, the number of clients and amount of work completed in the South Haven area has increased dramatically. The goal of the new warehouse and office on the property is to service South Haven area clients without having to mobilize multiple crews 40 miles each day. Additionally, we would like to add team members from the South Haven area to service our clients in the same area.

The proposed use of the property is an office to provide support for client service and team leadership at the branch, and also a warehouse for storage and preventative maintenance of lawn service equipment. Crews operating out of the site would primarily be lawn service and landscape maintenance team members. Typical company vehicles used by those crews include ¾ ton pickups with dump or utility trailers as well as 1 ton trucks with dump beds. The vehicle parking area would be fenced for security. There would be concrete block bins in the fenced area to hold an average of 50 cubic yards of mulch, stone and soil for use on client properties. The site landscaping would complement the nature of the business.

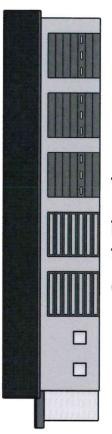

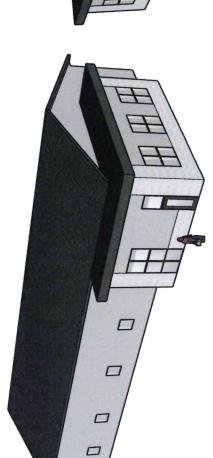

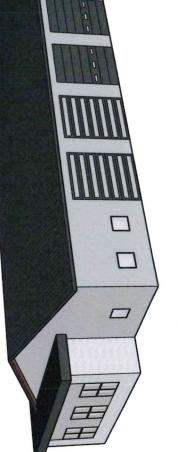
