- 8) New Business
 - a. Master Plan Kick off Brad Kotrba and Aman Pannu gave a presentation about the update to the Master Plan. Went over 5 points: 1. Project Timeline; update will take about a year to complete. 2. Project Expectations; well-written plan, last master plan was done in 2008/9. 3. Consultant Expectation; need the PC to be productive, feedback, 4. Community Engagement; work on survey and community open house, engage the public. 5. Meeting Schedule; plan to have 6 in person meetings. 1st thing is to send a letter to the neighboring communities stating the Township is starting to update the master plan. Then we start; 1st thing in the plan is to update the outdated data and work on language for survey.
 - **b.** Proposed new text: temp use events, RV, chart dimension requirements Smalley presented proposed text to revise 18.28 Temp Transient Uses; streamline the text for ZA to approve temp use events and add more types of events such as food trucks, car shows, benefit dinners. Discussed at what point the PC would approve an event, number of people or location, etc. Smalley will work on draft and present at future meeting.

Smalley presented proposed text to revise Recreational Vehicle language 18.27 and 18.31. These two sections really do not regulate recreational vehicles, also includes mobile homes.

Proposed text is to change the terms to recreational vehicle(s) and give clearer regulation.

Smalley presented a revised chart for dimensional requirements; this is to streamline all the charts to be the same and use the same terms and format. The current chart of uses are all different and use different terms. The members were in agreement with the new format and text. Smalley will revised all the charts and present at a future meeting.

Shoreline Protection 14B.03, separate ZA and PC approving and give more approving to ZA, PC agreed on proposed text. #3 add G to Industrial district, typical business use outside, PC agreed on the proposed text. #4 18.20 swimming pool, few revisions, change 18inches to 24 inches, remove shall and replace with may. Poole pointed out the PC discussed having regulations for inground and above ground pools for fencing regulation. Smalley will work on proposed text for inground/above ground.
