  - a. Temp Use app fireworks tent 02959 73<sup>rd</sup> St yearly application from PPI Michigan Fireworks. Tent to be located in the Habitat for Humanity/H&R Block parking lot (by Menards/Walmart). June 10 July 10, sales June 17-July 5. Once the tent is up the fire department will inspect. Motion by Tippman to approve the application and site plan for temp fireworks tent, second by Nicol, 5-0 yes, motion passed.
  - **b.** Review horse rack track 2023 events, 72828 24<sup>th</sup> Ave, Jesse Gamino July 2022 the planning commission gave temp/provision approval for 2022 season with the condition the PC review the application, site plan and 2023 race schedule prior to any races in 2023. Smalley contacted the fire department and road commission for their final approval. 2022 they both gave temporary approval. Fire department gave final approval and road commission gave an ok for races but Gamino needs to update some information.

2023 schedule to start Apr 29 and end approx end October races to occur every other weekend, no more than 2 races a month. Track hours to be approx. from 9a – 10p. Races will be more like 11-5 window. Number of people projected to attend 80-400. 2022 races had approx. 80-300. Planning for 2 food trucks.

Motion by Odland to recommend approval of 2023 race events with the following conditions:

- 1. Another review with planning commission 2 months prior to the first event in 2024 to review any complaints, traffic issues, noise, fire department, number of people in attendance 2023 events.
- 2. No alcohol sales, no gambling, no unlicensed food trucks/food vendors
- 3. Loud speaker to be directed away from adjacent residences/dwellings
- 4. No other events, other than horse racing is allowed
- 5. Number of spectators not to exceed 900, or as approved by fire department for public safety. This does not include the horse riders and the trainers.
- 6. Final approvals from the fire department and road commission Second by Tippman, 5-0 yes, motion passes.

Brad Kotbra, Williams and Works gave update on survey: to date approx. 240 responses received. We need to come up with creative ways/ideas to get the word out. Local papers, radio, social media, township sign, hand out flyers, library, church, etc.
